

The Morgia Wealth Management team is now working remotely. The physical office is closed.

Each of us have access to email and have our mobile phones. If you need to reach us, we are available through traditional phone, email and cell phone.

If there is an emergency, we absolutely can meet you in person. You will need to call us to set an appointment. That will give us time to prepare for a safe and sanitized meeting to keep you and our team safe.

We will remind you periodically that we are working remotely and how to contact us. At the bottom of this email you will find our email addresses as a reminder of how to reach us if you have questions, need to talk about your portfolio or want to check up on us. Please remember that even though we are working remotely, we can still do the same things we do when the office is open. If you need **ANYTHING**, please reach out.
